# Empowering people of faith to make a difference for the common good!

More good news this week—it's good to be able to focus on some good news after feeling like we've had so much bad news over the past year!

Basketball star Brittney Griner was released yesterday from a Russian penal colony in a prisoner exchange, that while lopsided (the US released "Merchant of Death" Viktor Bout), will reunite Griner with her wife, Cherelle. BG (as she is known) is now on US soil in San Antonio for evaluation, but should be home for Christmas!



And for our family, friends, and neighbors who are in same sex and interracial marriages, Congress has now passed the Respect for Marriage Act with bipartisan support. While not perfect, it will ensure that all states will be required to honor these marriages, even if in the future they choose to prohibit such marriages

occurring in their own states should the Supreme Court choose to reverse the Obergefell decision of several years ago that made same sex marriage the law of the land.
